Delivery

Industry Standard Delivery Time Frames

- **Monthly** publications please allow up to four to six weeks for first delivery.
- **Bi-monthly** publications please allow up to six to eight weeks for first delivery.
- **Quarterly** publications please allow up to ten to twelve weeks for first delivery.
- **Special offers** please allow up to six weeks for delivery.
- **Back editions** please allow up to six weeks for delivery.
- **International** delivery please allow up to ten to twelve weeks for first delivery.

Payment Options

Payment is required upon purchase of subscription.
